

Collaboration at Sea - 2027 Conference & Cruise Fact Sheet

Conference registration and cruise ship package are two separate costs and must be paid separately to Connecting 4 Justice International (conference) and the travel agency (cruise ship).

CONFERENCE REGISTRATION COST

Paid to: Connecting 4 Justice International

Early Bird Conference Rate: \$200 per person*

**available through December 31, 2026, provided the cruise deposit has been paid by that date.*

Late Conference Rate: \$300 per person

- Conference registration can be purchased individually.
- Your cruise cabinmate does not have to register for the conference. Significant others welcome.
- Conference registration is paid separately from the cruise ship package.
- No credit card or platform fees or taxes charged in registration cost. Charitable receipt will be provided.
- 100% of your payment supports the work of C4JI, a 501(c)3 nonprofit organization. Thank you.

CRUISE SHIP COST

Paid to: Baileys Luxury Travel

Base Cost: for a two-person interior stateroom: \$944.00

- Cruise ship pricing varies depending on the stateroom selected with 3 options to choose from.
- Cruise ship bookings are for double occupancy per stateroom. If you wish to room alone, you will pay the double occupancy rate.
- If you wish to be potentially paired with another conference attendee in a stateroom, call our travel agent, Ms. Radika Bailey at 754-246-6174 and mention "Collaboration at Sea", to be added to a roommate request list. There is an option to pay for your half of a shared room on the cruise ship reservation site.
- A cruise payment plan is available. See the payment schedule for details.
- **Cruise fare includes** your stateroom with daily housekeeping, a variety of meals and casual dining options, select non-alcoholic beverages, and a wide range of entertainment and on board activities.
- Enjoy live shows, music, comedy, trivia, movies, swimming pools, hot tubs, fitness facilities, and sports activities included in your cruise fare.
- **Cruise pricing does NOT include** transportation to or from the ship, specialty dining, drink packages, Wi-Fi package, excursions, shopping, spa services, gratuities/tips, or other personal expenses.

IMPORTANT DATES

December 31, 2026 - Deadline to secure \$200 early bird conference rate by paying your cruise deposit.

January 1, 2027 - Conference registration cost increases to \$300.

February 5, 2027 - Registration for both the conference and cruise ship closes.

Please note: Cruise pricing is based on a two-person occupancy and will vary based on the stateroom selected. The conference fee is separate and not included in the cruise ship price.
